75% of the fees for the training course provided by CICES HK Region and the eligible attendees will only need to pay 25% of the course fee. CICES HK Region will provide the training courses on NEC Professional Course and BIM Course respectively, the details will be announced to the members later this year when all the proper procurement procedures are completed.

26 March 2021: CICES Hong Kong Region held the Annual General Meeting by Zoom and there was over 25 Members joining the event. The President Steve Slessor (Left




Photo bottom right) and CEO Ann Allen MBE (Left Photo bottom left) also joined the AGM and gave

#### **Regional Chair Meeting**


