### **Abstract**

General Condition of Contract (GCC) is commonly adopted in various Government Contracts in Hong Kong. It serves as a tool and guideline to handle problems in different situations and resolve disputes among parties in a Contract. A thorough understanding on the GCC clauses is therefore considered as an essential element for running the contract in a smooth manner in the view of contract administration. Mr. David Leung will give a talk on this topic which covers the following issues:-

- Basic concept of a contract, including offer and acceptance, consideration and intention to create legal relationship.
- Application and analysis of GCC under various situations
- How to use clauses in the GCC to handle problems in a Contract
