Abstract

The Hong Kong Housing Authority encourages innovations for green design and construction. In 2009, they have launched an innovative "3-Envelope System" to procure an integrated design and build contract on a 5.7-hectare site with existing piles at Kai Tak Site 1B. It offers a unique opportunity with constraints for tenderers to innovate in the delivery of some 8,000 flats with a greening ratio exceeding 30%. The additional Envelope requires tenderers to propose any specific Innovations plus the corresponding price adjustments. This is the first of its kind in Hong Kong.

Ada Fung will examine the different approaches taken to the allocation of the risk in different types of procurement, and describe the development of the integrated contract as well as detailed operation of the 3-envelope system having regard to the risk appetite of the Hong Kong Housing Authority.
