The upshot of today's market for high value major construction projects, often with rapid turnaround, is much increased scope for differences and potential for disputes. Genuine pre-estimate of loss, notice of default, mitigation of loss, time limitation and terms of settlement are some of the catch phrases which can assist with properly managing dispute resolution with a view to achieving a better outcome, and more time and cost effectively. This seminar will discuss these topics and others relating to construction dispute resolution.
