

Security of Payment Legislation in Hong Kong?

Since the United Kingdom introduced statutory adjudication and payment legislation nearly 20 years ago, many other jurisdictions, including Australia and Singapore, have followed suit. Hong Kong is now gearing up with its own proposed Security of Payment legislation. A consultation paper was issued by a working group established by the Hong Kong Government on 1 June 2015 setting out key aspects of the proposed legislation, with interested parties being invited to give comments by 31 August 2015. The consultation paper set out the key issues considered by the working group in relation to each of the key aspects of the proposed legislation.

The aim of any such legislation is twofold. Firstly, to stop unjustified delay of cash flowing through the supply chain by seeking to ensure that contractors and subcontractors have a right to periodic payments. Secondly, to introduce a fast track dispute resolution process to ensure problems are resolved quickly during a project.
